Please send your proposal by making a request on your letter head so as to reach us latest by 31.12.2011. Please note that minimum number of candidates for any Centre is 20 and other details will be sent to you very shortly. The copy of the “Guidelines” to organise the STO Examination is being enclosed herewith for your kind perusal.
- It has been decided that each affiliated unit has to send the “**ANNUAL REPORT**” of their unit latest by 31<sup>st</sup> December 2011. This report must accompany the list of Athletes from your unit in the Performa which was sent to you with previous circular. This is mandatory for all the affiliated units to comply with.
- The “**45<sup>th</sup> U. P. State Cross Country Championships 2011-2012**” will be organised on 10<sup>th</sup> December 2011 (Saturday) by DAA Azamgarh at AZAMGARH. The details of the Championships were sent to you with previous circular. The Railway concession is being enclosed herewith for your kind perusal.
- The “**U.P. State Doping & Technical Seminar/Workshop**” is rescheduled and now it may be organised on 8<sup>th</sup> January 2012 (Sunday) at Lucknow.
