It was decided by the Technical Committee(Examination) to conduct the Federation State Technical Officials'(FSTO), Federation Technical Officials'(FTO) and National Technical officials Examination as per following schedule:-

FSTO Examination	State wise
Date of Examination	17th, 18th and 19th October, 2014 (17th and 18th Workshop and 19th Theory and Practical Examination)

Last date for receipt of Application form along with Examination Fee – 30th September, 2014

Examination fee - Rs.1000/- per candidate out of which Rs.500/- each candidate will be sent by Bank Draft in favour of 'Athletics Federation of India' payable at New Delhi and Rs.500/- each candidate will be retained by the unit for arrangement of examination at their center.

All the state Secretaries are requested to take appropriate action, so that all the interested candidates have opportunity to appear in the Examination. A wide publicity should be given through the News Papers for the purpose.

The State Secretaries are also requested to fix the Center in their state at such place from where the maximum number of candidates are willing to appear in the FSTO Examination and inform the Federation regarding place of Examination Center.

Last date for the receipt of application – 19th November, 2014.

Examination fee - Rs. 2000/- per candidate will be sent by Bank Draft in favour of 'Athletics Federation of India" payable at New Delhi.

TERMS AND CONDITIONS FOR CONDUCTING FSTO, FTO and NTO Examinations.

1. The examination will be organized under the sole authority of AFI with the supervision and responsibility of Federation Examination Committee. The examination will be conducted on the request of the Secretary of State Athletics Association on receipt of application and approval of the Secretary, AFI
2. FSTO examination at 1 centre in willing State and application received in time.
3. FTO Examination will be on Zone basis. 1 centre in each zone.
4. NTO Examination on centralized basis, which will be decided on receipt of applications.
5. The examination paper will be set and paper will be examined by the observer-cum-examiners nominated by the Examination Committee and he will be responsible for the conduct of two day seminar for the revision of IAAF technical conduct, latest rules and third day, theory and practical examinations along with physical ability test at last.
6. The academic qualification is higher secondary passed with the exception in case of National/International Athletes /Physical Educationist and women candidates. The examination will be conducted in English.
7. The maximum age limit for the candidates will be as FSTO -40 years, FTO- 45 years and NTO – 50 years. He/She must complete 1000 Meters Walk/ run within seven minutes time.
6. All the arrangement to conduct of examination is responsibility of organizing

State Athletics Association under the authority of Athletics Federation of India and

per day must be paid by the organizing State Athletics Association.

7. The examination will be conducted within total three days as mentioned in circular.
8. The examination will be conducted in theory and practical 100 marks each
Category and 75% marks is required for pass in theory and practical separately.
9. The syllabus of examination is “IAAF Competition Rules Book-2013-2014”

GUIDELINES, INSTRUCTION AND REQUIREMENTS.

- a. **Duly filled application in prescribed performa for all the Examination must reach to the office of AFI in time as mentioned for the different Examinations.** The Registration on prescribed form(for all those candidate who have submitted application with Examination Fee) will be held at the venue of examination at 09 AM on first day of concerned examination.
- b. **Secretary of State Athletics Association will send a consolidated details of all the applicant in a performa attached herewith.**
- c. **The first day, Inauguration of the Seminar will be held at 9.30 a.m. only not more than half an hour time and the Seminar will be started at 10.00 a.m. and will continue at the end of first/second day with Open House Discussion between candidates on the IAAF Athletics Competitions Rules at the last.**
- d. **The nominated Observer-Cum-Examiner with Local lecturers* will be allowed to speak only on one subject and review the matters of IAAF Athletics Competition Rules Handbook. 2013-14.*Local lecturer means all NTO'S and IAAF level 1 passed officials of state."**
- e. **TA & DA to outstation Federation nominated lecturers-cum-examiners should be paid by the organizing state as per the AFI norms. Railway Ticket 2rd AC. Both ways fare with DA for three/four day's @Rs.500/- per day and free accommodation with local transport facilities will be provided.**
- f. **Adequate facilities for organizing the Seminar should be extended depending on the number of candidates appearing for the Examination. It is advised that suitable examination hall with all necessary arrangements should be done.**
- g. **During the Seminar/Examination, Tea/snacks (at least two times in a day), and Lunch also should be arranged by the organizing State Athletics Associations from the amount deposited by the candidates for the purpose.**

IMPORTANT:

1. **THE THEORY EXAMINATION PAPER PACKET MUST BE OPENED INFRONT/PRESENCE OF THE STATE SECRETARY, LECTURER-CUM-EXAMINERS AND CONDIDATES ONLY HALF HOUR BEFORE AND LECTURER-CUM-EXAMINER.**
2. **THE THEORY EXAMINATION WILL BE CONDUCTED THIRD DAY BETWEEN 09. TO 11.00 AM AND THEORY ANSWER BOOKS MUST BE PACKED AS SOON AS THEORY EXAMINATION IS OVER IN PRESENCE OF THE CANDIDATES. THIS WILL BE FOLLOWED BY PRACTICAL/VIVA TESTS AND AT THE END OF PRACTICAL EXAMINATION. THE SEALED PACKED ENVELOP MUST BE SENT TO THE UNDERSIGNED ALONG WITH CANDIDATES REGISTRATION FORMS, PRACTICAL/VIVA MARKS.**
3. **THE RESULTS WILL DECLARE WITH IN 30 DAYS BY FEDERATION AND THE CERTIFITES FOR PASS CANDIDATES WILL ALSO BE IUSED BY FEDERATION.**
